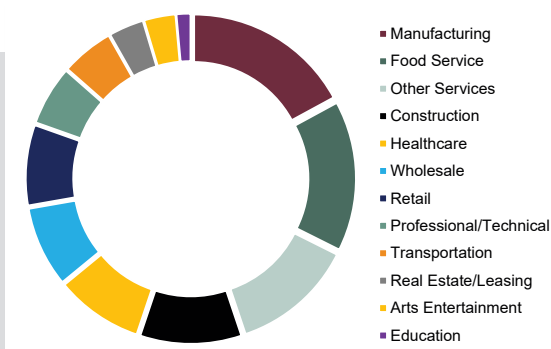

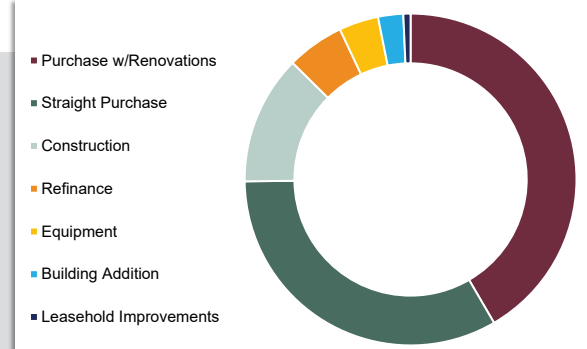


## THOUSANDS OF TRANSACTIONS, SPANNING A VARIETY OF INDUSTRIES
